

2017 Contract Production Rider



PLEASE NOTE: THIS RIDER'S REQUIREMENTS ARE SUBJECT TO CHANGE BY REQUEST OF THE ARTIST'S PRODUCTION MANAGER ALONE. THE ARTIST IS ENTITLED TO A FULL AND ACCURATE COMPLETION OF THE RIDER, UNLESS OTHERWISE AGREED UPON IN THE BOOKING PROCESS.

THIS RIDER: is made an integral part of the contract to which it is attached. NO DELETIONS, ADDITIONS OR CHANGES shall be accepted without expressed written consent of Artist's representative.

TECHNICAL SUPPORT:

Purchaser will provide:

- -(3) LOADERS to assist Artist's crew with load-in & load-out.
- -(2) hours setup time PRIOR TO SOUNDCHECK.
- -Competent technical personnel to operate FOH, MONITORS, AND LIGHTS (including 2 spot light operators). These technicians will cooperate fully with Artist's technical personnel in the operation of sound and light systems.
- -All technical personnel will be available for a one-hour soundcheck at a mutually agreeable time.

SOUND SYSTEMS:

Purchaser shall provide at his/her sole expense - first class p.a. and monitors with the following minimum requirements:

- -Mixing board must have 40 channels, with EQ and compression for each channel.
- -House system must be 3 or 4 way active crossed/ 3rd octave EQ and capable of producing at least 113 dB at 100 feet with frequency response ranging from 20Hz to 20kHz.
- -Sufficient cable to connect all microphones to the mixer station.
- -Multiple reverbs and delays available for mix.

MONITORS:

Purchaser will provide:

- -An on-stage monitor mix that is separate & independent of the (audience) mix.
- -(1) Monitor board capable of incorporating the signals of at least Ten (10) monitor "wedges" with ten separate mixes, as well as two (2) 3-way side fill cabinets.
- -(10) "Wedges"
- -(1) Sub (for drummer)
- -(2) Side fill cabinets.
- -EQ and compression/limiting for every channel

MICROPHONES AND STANDS:

MICS: (4) Sen. 421's // (4) Shure Beta 58's // (2) Shure SM 58's // (7) Shure SM57's // (3) AKG 451 // (1) Shure Beta 52 or AKG D112 // (5) DI Boxes w/ Ground Lift Switches

MIC STANDS: (8) Short Boom // (5) Med. Boom // (12) Regular Boom // (3) Straight

LIGHTS:

Lighting system should have no less than 16 channels, covering a minimum of no less than 64 assorted lighting units (FOUR OF WHICH MUST BE "INTELLI-BEAM" OR EQUIVALENT), and adequate dimming board with 2400 Watts power per channel (NO ETA LIGHTING SYSTEMS PLEASE). There should be at least two spotlights plus experienced operators. In addition, there should be a clear communications link between lighting director and spotlight operator(s).

STAGE:

Purchaser shall provide a stage with:

- -No less than 32' wide and 24' deep with sound wings.
- -CARPETED drum riser at least 8' X 8' and a **RUG** at least 4'x4' for the drum area.
- -Keyboard riser at least 8' X 6'.
- -None of Artist's instruments or equipment is to be moved after soundcheck except with specific consent of Artist or Artist's technical representative.
- -If performance is out of doors, Purchaser agrees to provide a covered stage. In the event of hazardous conditions due to weather or other, Artist shall be paid in full and shall not be required to perform.

BACKLINE REQUIREMENTS:

PURCHASER HAS AGREED TO PAY FOR BACKLINE, AND <u>MUST FULFILL ALL</u> <u>REQUIREMENTS</u>. NO SUBSTITUTIONS ARE TO BE MADE FOR ALTERNATE GEAR.



2017 Logistical/Hospitality Rider



1. THIS RIDER: is made an integral part of the contract to which it is attached. NO DELETIONS, ADDITIONS OR CHANGES shall be accepted without expressed written consent of Artist's representative. A "Production Rider" shall also accompany this rider.

2. CONTACT:

- 3. BILLING: Unless otherwise stipulated in writing, as in the case of engagements wherein Artist shall receive 100% HEADLINE BILLING as follows:
- 4. PAYMENT: Cash or check to be made out to "Secret Knock, LLC". Checks made out to anyone else will not be accepted.
- 5. PASSES: Purchaser agrees to provide Artist with Twenty-five (25) complimentary admission and backstage passes. In the event passes are not being used, Purchaser will provide complimentary admission to the venue and backstage area to Twenty-Five (25) guests of Artist. Purchaser shall be limited to Twenty-Five (25) complimentary passes for Purchaser's staff and guests, unless Artist has granted previous consent.

- 6. DRESSING ROOM: Purchaser agrees to provide at least 2 (TWO) clean, well-lit and comfortable dressing rooms- sufficiently heated (in cool weather)/ or cooled (in warm weather). One dressing room shall have comfortable furniture sufficient for 14 (FOURTEEN) persons and a private lavatory, and one shall have adequate lighting and mirrors for makeup, etc... Purchaser will provide adequate security for dressing rooms, or provide Artist with keys if dressing rooms are lockable. Purchaser also agrees to provide adequate stage and backstage security before, during, and after performance. Purchaser assumes responsibility for safety of Artist's personnel and belonging from time of load in until time of load out.
- 7. PARKING: Secure, LEGAL parking space, adjacent to venue back stage entrance, SHALL be provided for Artist's vehicles. These may include ONE cargo van and THREE luxury automobiles.
- 8. HOSPITALITY: (1) Purchaser shall, by prior arrangement with Lewis Robertson: Provide a nutritious hot meal of both vegetarian & non-vegetarian foods, for Eight (8) hungry people -OR- a \$25 cash buyout per person for same ... NO EXCEPTIONS! (2) Purchaser shall provide the following in Artist's dressing room, 30 minutes prior to soundcheck.

NOTE: SEVERE PEANUT ALLERGY

One (1) deli tray (i.e.: fresh roast beef, turkey, cheeses - no processed 'mystery' meat or Velveeta please), fresh whole wheat & snacks (chips, Doritos, & pretzels), mayonnaise (not Miracle Whip), Pickles, Dijon and regular mustard, salt & pepper.

-Two (2) lbs. fresh raw vegetables

-Two (2) lbs. fresh fruit

-One (1) case of IPA Beer

-One (1) bottle of Tito's Vodka w/Lime

-One (1) 12 Pack of non-sparkling bottled water

-(1) 12 Pack or Two 2-Litre Club Soda or Seltzer

-One (1) gallon cranberry juice

-Six (6) Health Bars

-Two (2) six packs of SMART water

-One (1) Six Pack of Coca Cola and Sprite

- -Twelve (12) large, clean, dry cotton towels VERY IMPORTANT!!!
- 8A. HOTEL ACCOMMODATIONS: In the event contract calls for Purchaser to provide & pay for Artist's hotel accommodations, the following simple amenities MUST be available at said hotel. THERE CAN BE NO EXCEPTIONS (a) Hotel MUST be of minimum 3 (three) star quality. (b) Hotel MUST have windows that open. This is an important health issue for several band members. Absolutely NO 'sealed-in glass hotels' please! (c) Hotel must have the availability of room service. (d) Hotel MUST HAVE FREE WI-FI ACCESS IN EACH ROOM. Artist shall assume complete responsibility for payment of all room service & incidental charges.
- 9. MERCHANDISING: Artist reserves the exclusive right to manufacture, sell & distribute souvenirs (including but not limited to clothing, photos, posters, sound recordings and video). In the event Purchaser oversees sale of the above, Artist's representative shall review manifest of goods with Purchaser, which Purchaser shall sign, prior to opening of doors. At the end of the performance, Purchaser shall conduct a fair and prompt reconciliation with Artist's representative. Therein, Purchaser shall be entitled to a mutually agreeable percentage for gross sale of said goods

10. TAPING: Artist reserves the exclusive right to video and/ or audio record Artist's performance for any and all purposes.

11. GENERAL:

- A) Purchaser must notify Artist concerning existing ('blue') laws in Purchaser's municipality that might penalize Artist for use of certain language from the stage.
- B) Artist reserves the right to substitute for any musician, in case of illness.
- C) Artist may cancel this engagement without penalty or further commitment to Purchaser, upon 40 (FORTY) days written notice.
- D) If Purchaser fails to remit SIGNED CONTRACTS and REQUIRED DEPOSIT by the DUE DATE specified on CONTRACT FACE, Artist may cancel this engagement without prejudice to Artist's right to seek the FULL CONTRACT PRICE PLUS DAMAGES as determined by a court of law in the State of California.
- 12. FORCE MAJEUR: In the event of fire, flood, civil strife, illness, injury or death, failure of transport or other such occurrence beyond Artist's control- Artist shall not be required to perform. Purchaser specifically accepts all terms of this rider, unless Artist waives them. Such waiver shall be effective only if initiated by both Artist and Purchaser. Purchaser agrees to and hereby indemnifies Artist, saves and holds them harmless from any and all loss and damage (including reasonable attorney's fees) arising out of or connected with breach by Purchaser of any of the warranties, representations, and covenants herein made or made in the attached contract.

In consideration of the terms proscribed above, the parties hereunto set their hands and seals below, acknowledging and accepting fully the terms stated herewith.
